Whereas in exercising the power conferred under clause (13) of the Income Tax of the original Trust deed of "**ARC EDUCATIONAL TRUST**" ^{Pachampalayam, Padaiveedu} the following amendments are made in the Trust Deed with immediate effect.

Amendment No.1:

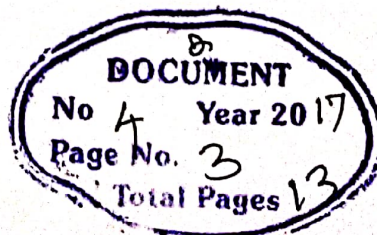
The following clause is DELETED from Board of Trustees in Page 3 of Original Trust Deed , *that is,*

In the event of Death, resignation of the Trustees, his legal heirs or a person appointed by the above member may become a Trustee for his life subject to the approval and concern of the majority of the remaining Trustees.

Amendment No.2:

Clause No.8 of Rights obligations and Privileges of the Trustees is DELETED from Board of Trustees in Page 8 of Original Trust Deed. that is

Trustees can transfer his or her membership to his or her legal heirs (Viz. Husband, Wife, Son, Daughter)

Amendment No.3:

Clause No.9 of Rights obligations and Privileges of the Trustees is DELETED from Board of Trustees in Page 8 of Original Trust Deed. that is

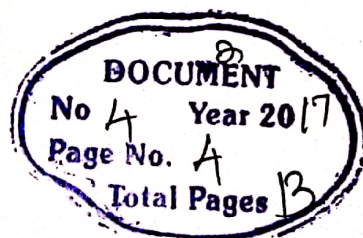
In instance where there is no legal heir to trustee or when such legal heir resides abroad or its not interested it becoming a member than such trustee may nominate his or her brother, sister or any of their kins folk legal heir to be the Succeeding member in his or her place however in such case Board of Trustees decision is final.

Amendment No.4:

The following additional clauses are inserted at the end
The Trust shall be irrevocable.

That the trustees may invest the trust fund in purchase or mortgage of immovable properties or in a manner as permissible in land and to convert , alter, vary, dispose of or transfer such investment as per the Provisions of 11(5) of the Income Tax Act from time to time provided such investments shall not be made which are directly or indirectly for the benefit of any person referred in section 13(1) (d) read with section 11(5) of the Income Tax Act or any subsequent amendments as made from time to time.

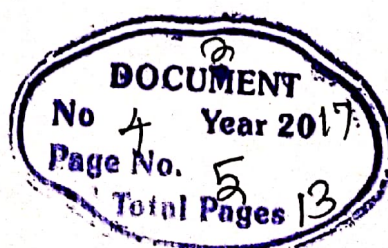
The funds of the Trust shall be exclusively used for the objects of the Trust, and the Surplus That if the income from the trust property in a particular year is not fully utilized, the unexpended income shall be carried over to the next year subject to the provisions of section 11 of the Income Tax Act applicable to the trusts and spent in such subsequent year for the advancement of the object of the trust.

In the case of dissolution of Trust, the Trustees shall transfer the assets to another Trust whose objects are similar to this Society and it shall not be distributed.

Any amendment to the Clause shall be made with the prior approval of the Commissioner of Income Tax.

That no person being an undischarged insolvent or convict of an offence involving moral turpitude or of unsound mind or a minor shall be eligible to be a trustee.

If any of the Trustees acts against the objects of the Trust and as a consequence of which any loss occurs to the Trust, the same has to be recovered from the Trustees.

If any person intends to join the Trust as a Trustee he has to be admitted only with the approval of other Trustees and he has to abide by the rules of the Trust. The Board has power to remove any Trustee if he acts against the Trust objects or against the welfare of the Trust.

The Trust Income should be exclusively applied for the purpose of the Trust and for obtaining the objects of the Trust.

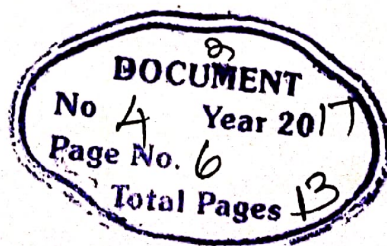
The benefits of the Trust is open to all irrespective of the caste, religion, sex, etc.,

These trust shall not carry on any activity outside India.

The Trust shall not carry on any activity with the intention of earning profits.
